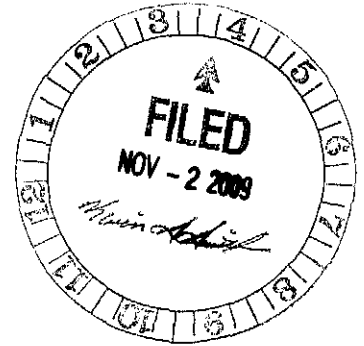

ORDER APPOINTING JUDGE PRO TEMPORE

On October 14, 2009, this Court issued an Order suspending the Honorable David Andrew Moreland, Judge of the Bicknell City Court, effective at 12:00 a.m. on October 14, 2009, pursuant to Indiana Admission and Discipline Rule 25(V)(A). As a result, the appointment of a Judge *Pro Tempore* is necessary for the Bicknell City Court. Accordingly, we find that in the interests of continuing the orderly administration of justice and pursuant to Ind. Trial Rule 63, a Judge *Pro Tempore* should be appointed temporarily to discharge the duties of that office. Further, this Court has been advised that the Honorable Michael D. Edwards, an attorney admitted to practice law in this state, is willing to serve as Judge *Pro Tempore*.

IT IS, THEREFORE, ORDERED that that the Honorable Michael D. Edwards is appointed as Judge *Pro Tempore* in the Bicknell City Court effective November 16, 2009. This appointment will continue in effect until further order of this Court.

This Order shall be sufficient authority for Judge Edwards to continue the employment of court personnel and otherwise discharge the duties of Judge of the Bicknell City Court. Judge Edwards shall be entitled to compensation for this service paid from the funds of the City of Bicknell at the same rate and on the same schedule as the present incumbent, commencing from the effective date of his appointment.
