9/13/04	A MAJORITY OF THE COURT HAS CONCLUDED THAT THE MOTION TO ACCEPT JURISDICTION SHOULD BE AND IT THEREFORE IS GRANTED. HAVING ACCEPTED JURISDICTION OVER THE APPEAL, WE NOW CONSIDER "APPELLEE'S VERIFIED MOTION TO SHORTEN DEADLINES," AND "APPELLANTS' RESPONSE TO APPELLEE'S VERIFIED MOTION TO SHORTEN DEADLINES." THE COURT DIRECTS THE TRIAL COURT TO TAKE APPROPRIATE ACTION TO ENSURE THAT THE WORK NECESSARY TO THE FILING OF THE NOTICE OF COMPLETION OF TRANSCRIPT BE COMPLETED AND THE NOTICE BE ON FILE NO LATER THAN THIRTY DAYS FROM THE DATE OF THIS ORDER.
